

## Barn Hunt

\*These trials will be held outdoors, under cover on a hard packed dirt floor, in a securely fenced area. Blinds will be placed on the same dirt floor within the allowed distance to their perspective rings. At all times, the safety of the dogs, handlers, and rats will be of paramount importance.

\*You may crate your dog at the west end of Building "D" in the marked crating area. Please bring a secure crate, slip lead and plenty of water for your dog. A grassy area is adjacent to the building for exercising your dog before they go into the ring. Please pick up after your dog.

\*Parking allowed in Building "B" along with crating in your car.

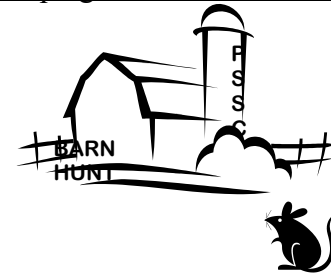

**Directions to the trial site:** The trial will be held at the McLean County Ag Expo Center (aka Interstate Center) 2301 W Market St., Building C, Bloomington, IL 61705.

**Routes to the site:**

From north take I-55 south to Rt. 9 – exit 160B – west 1 mile, site on the right  
From the south take I-55 north/I-74 west to Rt. 9 – exit 160B – west 1 mile  
From west take I-74 east to Rt. 9 – exit 160B – west 1 mile

**Check in:** Friday 4:15 Briefing at 4:30pm; Saturday 7:30 - 8:15am;  
Sunday 7:30 – 8:15 am

**Judges briefing:** **Friday** -4:30 pm with the first dog on the line at 5:00pm **Saturday and Sunday-** 8:15am., first dog on the line 8:30 each day

**Running order may change at judges' discretion**

**Saturday** Trial 1 - Ring 1 (instinct, novice, open) followed by Trial 2 (novice, open); Trial 1 - Ring 2 (senior, master) followed by Trial 2 (senior, master)

**Sunday** Trial 3 - Ring 1 (instinct, novice, open) followed by Trial 4 (novice, open); Trial 3 - Ring 2 (senior, master) followed by Trial 4 (senior, master)

**Running order** each day by height (small, medium, large).

Dogs being handled by the same person will be separated into different staged groups.

Bitches in season will run at the end of the class with panties securely on.

**Height divisions:** Dogs 13" and under small Dogs 13.1 to 18" medium Dogs over 18" large

Exit test site turning left (east) onto Rt. 9 (Market St). Keep to the right. Take I-55/74 south. Keep left. Stay on I-74 east. Take first exit 134B (Veterans Parkway). Go north on Veterans Parkway to Oakland Ave (Walgreens drugstore on SW corner, Denny's restaurant on SE corner of this intersection) Turn left onto Oakland Ave. Keep to the left. Clinic is on the left in the first block, next to Concord Cleaners.

**Exhibitor Information:**

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct test. Dogs earning a title in Trial 1 may be moved up to the next class for Trial 2 but are not required to move up. Move-ups will be accepted on Saturday and Sunday up until 30 minutes before the start of the second trial that day. Move-up forms will be available at the secretary's table.

**All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50.00 fee for all returned checks. Unsigned entries, incomplete or incorrect barn hunt numbers, illegible or incomplete entries or conditional entries are considered invalid. No phone or electronic entries accepted,**

The safety of the dogs is our primary concern. By entering this test, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Rules can be found at <http://barnhunt.com>

It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the test committee, may be asked to leave the test site. In that case, no refund of any fees paid will be made.

Dog exercise areas will be marked, please pick up after your dog and dispose of waste in appropriate containers in the area. Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

**Collars and Leashes;** Electronic collars and devices are not allowed on test grounds. Head halters are not allowed on test grounds. At no time should dogs be tied out or otherwise left attached to something other than a human. Dogs may not be brought to the line in any disallowed collar. Dogs may not be brought to the line on flexi-leads. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced. All dogs must be on leash at all times except when in the ring.

**Refunds;** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

**Bitches in season** are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class. Entry fees for bitches that come into season will be refunded until closing time of the test if you wish to withdraw; requests for refunds must be accompanied by a letter/email from your veterinarian. After the trial closes on September 12, 2016, entry fees will not be refunded for a cancellation. *If bringing a bitch in season, please inform the trial committee prior to the trial, and you must inform all exhibitors at the judge's briefing.*

**Loud/Disruptive dogs:** Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete.

\*Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found by the judge and/or trial committee.

\*Terrier sparring is not allowed on trial grounds.

\* Any dog that is sick or lame will be excused from the trial grounds.
