General Information and Policies

It is the responsibility of each competitor to read and understand the current Barn Hunt Association, LLC (BHA) Rules prior to participating in this event. <http://www.barnhunt.com/forms/barnhuntrules.pdf>

Possessing or training with personal tubes and/or live rats is NOT permitted on the event grounds at any time.

Events will be held indoors on mats. Dogs must be leashed or crated when not in the blind or ring. Crating is outside, please bring tents as there is limited shade. Please pick up after your dog and dispose of waste in appropriate containers. Multiple potty areas are available.

Barn Hunt Grounds: These trials are a part of The Savannah Kennel Club Annual AKC All-Breed Dog Show. Barn Hunt rules apply to any activities held in Warehouse building. The grounds, including parking, that surround the Warehouse building will be subject to both BHA and AKC rules depending on which events a competitor is entered. There will be a potty area that is designated for BHA competitors and you must pick up after your dogs on the trial grounds and at the hotel. .

Leashes and collars: See BHA Rulebook page 20 for specific information on what is allowed Flexi-Leads are NOT allowed on event grounds.

Dog aggression: Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the event if justification is found by the judge and/or Event Committee. Entry fees will not be refunded.

Bitches in season: Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class. They must wear pants at all times (including on course) while not being pottied. They must be pottied in a designated area away from the other dogs. Entry fees for bitches that come into season will be refunded until the closing date of November 29, 2017, if you wish to withdraw. **The trial secretary must be notified prior to or upon arrival. Failure to do so will result in a disqualification and dismissal from the event.**

Videotaping and photography: Is allowed and encouraged!

Volunteers: Are appreciated and needed!

Spectators: Are valued and encouraged! Please be sure spectators have a basic understanding of the sport, plus do's and don'ts.

Sportsmanship: All competitors/handlers and spectators are expected to follow the rules of the BHA and demonstrate good sportsmanship. Please do not discuss hide placement or any details of a dog's performance that may provide information or clues to other handlers or may be overheard. Please be cognizant of teams competing in the ring and avoid loud or disruptive distractions.

Crating: Dogs must be leashed or crated when not actively working, and never tied out/left attached to anything other than a human. Crating space available outside, on grounds or in vehicles.

Food services: Hot Java

Payment and entry information: Entries will NOT be accepted without signatures and payment, entries are invalid without a signed Release Agreement Form. Owners are responsible for entry errors. Please write clearly and proof your entry. BHA will not make corrections once results are submitted. Incomplete forms, nonpayment, and returned checks are invalid entries. There is a \$25.00 fee for all returned checks. Entries accepted on a first come/first served basis.

Refunds are ONLY allowed if requested before the closing date of November 29, 2017

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, excused, or barred from competition by action of the Event Committee.

BHA registration number IS required!

You can register your dog on line at <http://www.barnhunt.com>. BHA registration fee is \$30, and **is a lifetime fee for that dog**. There are no annual fees with BHA, and no membership fees for dog owners.

The Savannah Kennel Club, Inc. reserves the right to decline entries for cause and may remove any dog on account of dog or human aggression. No one shall have any recourse or claim against The Savannah Kennel Club, Inc., or any agent thereof.

Certification of Agreement upon Registration or Entry of Dog

I certify that I am the actual owner of the dog(s), or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of the **Barn Hunt Association, LLC or The Savannah Kennel Club, Inc.
