CLUB RULES IN ADDITION TO BARN HUNT RULES

- I. The trials will be held outside, not heated or air conditioned.
- II. Both rings will run simultaneously. **Format is: Fri TR1- Open, Inst, Nov; Sen., 8s, Mstr. Fri TR2- Mstr,8s. Sat- Inst3, Nov3, Nov4, Open3, Open 4; 8s3, 8s4, Sen3, Sen4, Mstr3, Mstr4. Sun TR5 Open, Inst, Nov; Mstr, Sen, 8s.** Final details will be mailed prior to the trials. We reserve the right to make changes to the schedule.
- III. All dogs must be on a short leash and under control while on trial grounds except while showing. **Covered prong collars with a snap ARE PERMITTED. Flexi leashes, electric collars & uncovered prong collars are NOT PERMITTED at the show site.**
- IV. There is **NO SMOKING WITH LIT CIGARETTES** around the rings. **E-Cig** are allowed but must be 50 feet from the rings per BH rules.
- V. Please pick up after your dog and **dispose of waste** in appropriate containers—trash cans. Please clean up after yourself. Do not put dog waste in the metal burn barrels.
- VI. **Please do NOT walk your dog in our neighborhood. Stay on our property.** Lots of livestock on the other properties. Dogs cannot be tied out to anything except a human.
- VII. **Bitches in season** MAY compete at Barn Hunt events. They will be ran at the end of each class. Bitches in season must wear panties designed for dogs. If bringing a bitch in season, inform the trial committee prior to the trial.
- VIII. First through fourth place qualifying ribbons will be given. Rosettes will be given for titles.
- IX. **Refunds will only be given for withdrawals made prior to the closing date.** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- X. **NO** Camping on our property. RV & Trailer space at the Pinal Co. Fairgrounds. Call them directly at 520-723-7881.
- XI. Every attempt will be made to hold this event as scheduled. In the event of an “Act of God” such as fire, flood, pandemic, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion or carry them over to another trial.
- XII. A returned check does not constitute a valid entry.
- XIII. **Disruptive dogs** will have to be crated a good distance from the ring. If your dog cannot handle other dogs or people walking past their crate, plan to crate farther away from the ring. Please bring adequate shade.
- XIV. We have **ONE** porta-potty. Disinfectant will be on table beside porta - potty. Please spray disinfectant in interior prior to using and after.

Directions:

From Phoenix: Take I-10 toward Casa Grande (Tucson) Exit at #194 (Promenade Mall) Turn left at the light and drive over the freeway. Go 9.3 miles east on a good 2 lane Hwy (287). At the end of the 9.3 miles you will see a neighborhood on your left (north). Turn left (north) onto Sunset Ln. We are on the left (west) side of the street behind the tall oleanders. Our address (158) is on our mailbox across from our double panel gate. Drive in and follow lane either way toward the barn hunt roof. Parking will be facing the field for Nov/Open or behind the white trailer for Sen, Mstr, Crzy8s.	.From Tucson: Take I-10 toward Casa Grande Take Exit 211 At the top of the ramp turn right, continue straight. Stay to the right at the fork. Drive approximately 10 miles, turn left (west) onto Hwy 287 toward Casa Grande. Go 2 streets, turn right (north) onto Sunset Ln. We are on the left (west) side of the street behind the tall oleanders. Our address (158) is on our mailbox across from our double panel gate. Drive in and follow lane either way toward the barn hunt roof or behind white office trailer. Parking will be facing the field for Nov/Open or behind the white trailer for Sen, Mstr, Crzy8s.
