Entry Information:

- A signed and dated Covid Waiver must be printed and brought with you to the trial. You can find the waiver at the end of this document.
- No toys, food or training will be permitted in the ring.
- Entries will be accepted by mail, in-person or [Venmo](#). Check, cash or [Venmo](#) are acceptable forms of payment. An entry is not considered valid until payment is received. Please DO NOT mail cash. • A returned check does not constitute a valid entry. A \$35.00 fee applies for all returned checks. • Owners are responsible for errors made on entry forms.
- Dogs with Rattitude at Dodger's Paws reserves the right to refuse an entry for any reason. You will be notified by email and your entry fee will be returned.
- All dogs must be on a fixed 6' leash and under control while on trial grounds except while in the ring. No retractable leashes, flexi leashes or long line leashes may be used.
- Barn Hunt Rules apply - NO Electronic collars, bark collars (including citronella, GPS, etc.), head halters, uncovered prongs, and muzzles
- Bitches in season (BIS) may compete at Barn Hunt Trials. They must wear pants and be kept separate from other dogs. BIS will run at the end of their class. Designated walking area will be assigned and they must crate out of their vehicle. Please inform the trial secretary when you arrive for additional information.
- Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or the trial committee. • The safety of the dogs and the rats are our primary concern. By entering this trial,

exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and physically able to perform all course elements.

- Smoking/Vaping is not permitted on trial grounds.
- Dogs With Rattitude at Dodger's Paws Club and Members assume no responsibility for any loss, damage, or Injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, vehicles or children.

Withdrawal and Refund Information:

- Withdrawal due to COVID-19: Attendees who enter a scheduled event but then must withdraw due to suspected or confirmed COVID-19 or direct exposure to/close contact with a COVID-19 patient will receive a full refund minus a club administration fee of 5%
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Cancellation Policy: Every attempt will be made to hold this event as scheduled. In the event of changes to Local COVID-19 restrictions, or an "Act of God" such as fire, flood, etc., the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. Entry fees will be refunded as appropriate.

Event Grounds / Ring / Blind Information:

- You may use any of the 3 large grass areas in the front of the complex to potty your dogs. Please pick-up after your dog and dispose of waste in the green dumpsters.
- Event grounds include the 39 California Ave Business Complex at 39 California Avenue, Pleasanton, CA 94566, specifically unit #305 which will be used as the Blind and Trial Secretary Area and unit #307 which is where the Barn Hunt ring is located. Please see [this map](#) for a visual of the location of the Barn Hunt ring. DO NOT turn into the U shaped driveway, go PAST that driveway and turn into the long driveway and park in that parking lot.
- There will be NO overnight parking on the test site
- The ring is located indoors with a concrete floor that is covered in foam matting. The ring will be enclosed with 4' PVC/Lattice fence.
- Blind area is 10'x20' and is located on the inside unit #305. There will be 5 Dogs per blind for Instinct, Novice, Open, Crazy 8's and Senior and 4 Dogs per blind for Masters. Each competitor will be assigned a numbered chair corresponding to their number in the blind. Competitors must stay in their numbered chair, not move their chair around, and exit the blind in order, not crossing the path of another competitor. There will be 3' tall barriers that will separate the competitors in order to reduce stress for the canine competitors.
- Exhibitors are responsible for being ready to go in blinds and for not holding up a class. The club has no obligation or responsibility to search for or locate a dog not brought to the ring when required.
- Competitors are encouraged to crate inside or beside their cars. There will be **NO INDOOR CRATING.**
- Please bring adequate water for you and your dogs.
- Human Restrooms are located in the front building of the complex and will be available for use. The rest rooms do not allow dogs so please contain your dog before approaching the restrooms. • There is no food available on site but many local restaurants to go to after the trial. Jasper (Martha & Niki's dog) Highly suggests going to Meadowlark Dairy and getting an ice cream cone!

Liability Waiver

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to win prizes, ribbons, and/or trophies, I (we) agree to hold Barn Hunt Association, LLC, Dogs With Rattitude at Dodger's Paws, their members, directors, governors, officers, agents, or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any BHA LLC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near
