Collars and Leads- IMPORTANT

Disallowed collars/attachments on all Barn Hunt grounds. The following are not allowed to be used on Barn Hunt grounds. Electronic collars, bark collars (including citronella, GPS, etc.), head halters, uncovered prongs, and muzzles.

Disallowed collars/attachments in the blind/ring. Leashes with attached dangling items; toys/tugs, poop bag holders.

Bitches in season

Bitches in season (BIS) MAY compete at Barn Hunt trial. They will be run at the end of each class. **Bitches in season must wear pants**

Height divisions are to equalize efforts for dogs of the same general size.

Small: Dogs 15" and under

Medium: Dogs 15.1 to 22"

Large: Dogs over 22"

Awards

Each division and height group will have awards through fourth place based on the elapsed time of marking the rat tube. Title rosettes will be awarded to dogs finishing a title. Fastest Dog in each division will receive a special prize and rosette. B divisions are placed with all heights combined except for Master which will have awards by height.

SPECIAL AWARDS: There will be a special award for the highest placed Rottweiler in each division.
