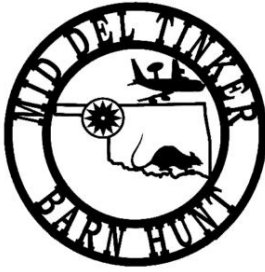

Permission has been granted by the Barn Hunt Association, LLC for the holding of these barn hunt trials under BHA Rules and Regulations.

Open to all Breeds and Mixed Breeds of all sizes!

A Barn Hunt Registration Number IS REQUIRED to enter this trial.

Trial Opening Date: April 27, 2024 at 10am central. Entries received before this date will be destroyed.

Pre-Entry Closing Date: June 12, 2024 at 10pm central or when entry limits are reached.

*\*\*Late entries will be accepted for an additional fee if space allows.\*\* Late entries are not a guaranteed entry and will be accepted only up to judging limits.*

Any changes to your entry (besides move-ups) must be done in writing before closing!

### ENTRY LIMIT:

Trial will be limited to approximately 8 hours of judging. Otherwise, until the Maximum Run Value (see BHA club rulebook) per judge limit is reached or per current emergency rules in effect. Judges are limited to 8 hours of judging and a maximum run value, which will require this Club to limit entries accordingly.

### CLASSES OFFERED:

Instinct, Novice, Open, Senior, Master, Crazy 8's. C8 will be twice per day for a total of six. A&B Classes where applicable. Dogs may enter both the Instinct class and Novice class in the same Trial until the dog has earned the RATN title and then they cannot enter the Instinct class any longer.

*\* NEW: Competitors may enter more than one class type per Event (e.g. Open B on Saturday and Senior A on Sunday).*

### MOVE UPS:

\*From another event can be made up until 24 hours prior to the start of the trial. Requests must be in writing. Please email: [middeltinkerbarnhunt@gmail.com](mailto:middeltinkerbarnhunt@gmail.com)

\*During the event if you title, you can move up to the next class for the next trial, except on the last day due to the running order. Move-ups must be submitted before the next class starts.

*\* NEW: Competitors can move down to a lower level on a following day of trials. You must let the Trial Secretary know before the end of the trial day (or sooner) for the next day.*

### BLIND INFORMATION:

Blind will be at least 200 square feet, located at least 15' away from the ring.

Instinct/Novice/Open will be blinds of up to 6 dogs. Senior & C8's will be blinds of up to 5.

Master will be blinds of 4-5.

Classes in **Ring 1** will be run concurrently! Instinct-Novice 1-Novice 2-Open 1-Open 2-Senior 2. Senior 2 in Ring 1 will be run after Open 2 to allow for move-ups from Open 1. Crazy 8 in **Ring 2** will be run in trial order. Senior 1-Crazy 8s-Crazy 8s. **Masters/Championship only in Ring 3.**

**PRELIMINARY SCHEDULE: (check the welcome letter for confirmed times)**  
**Thurs:** Building will open at 2pm, Briefing at 3:00pm, Fun Runs to follow.  
**Fri-Sun:** Building open 6am, Briefing at 7:30am, Trials to follow.  
**CHECK THE WELCOME LETTER FOR CONFIRMED TIMES!! This is an estimate!**  
Building will close no sooner than 30 minutes after the last dog of the day has run. Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

#### TRIAL GROUNDS:

Barn Hunt Grounds: These trials are a part of the AKC Oklahoma Summer Classic Cluster and other associated events. Barn Hunt rules apply to any activities held in the Modern Living Building. The grounds, all other buildings, parking that surround the Modern living Building will

be subject to AKC rules. There will be a potty area that is designated for BHA/AKC competitors, and they must pick up after their dogs on the trial grounds and at the hotel. There is an indoor restroom at the site. There is NO SMOKING in this facility or on the grounds.

The trial will be held indoors, on mats over concrete. There is cooling in the building but please dress appropriately for the outside weather. Please feel free to bring fans, power strips, extension cords, etc.

#### HEIGHT DIVISIONS:

- Dogs 15" and under - Small
- Dogs 15.1 to 22" - Medium
- Dogs over 22" - Large

#### VOLUNTEERS:

We need your help! A Volunteer Sign-Up sheet will be on site. We will need Gate Stewards, Rat Wranglers, Course Builders, Leash Runners, Scribes, and Sheet Runners. Information about each position is available at [www.BarnHunt.com](http://www.BarnHunt.com). Contact Show Chair for details

#### EXHIBITOR INFORMATION:

All dogs must be at least 6 months of age to compete in a Barn Hunt event.

All dogs must be on a short leash and under control while on trial grounds except while showing.

Per BHA rules: bark collars (including citronella, etc), head halters, uncovered prongs and muzzles are not allowed to be used on the trial grounds. Dogs are required to run "naked" and should be brought into the ring with collars/harnesses/slip leads which can be easily and quickly removed and replaced. Please see page 9 section 13 of the competitor rulebook for further information regarding collars and leashes.

#### FOOD:

Multiple food options are available onsite through concession stands. There are also numerous restaurants within minutes of the trial. See the welcome letter for more information.

#### CRATING:

Dogs must be leashed or crated when not actively working, and never tied out/left attached to anything other than a human. Crating space available inside, on grounds or in vehicles. Dogs may not be left in shared common crating area in Modern Living Building overnight. Dogs left by agents or owners in Bennet Event center grooming area overnight are requested to identify the dog's crate with an emergency phone number or information in case of an emergency. AKC crating policy will apply.

**IMPORTANT: Only soft or metal crates are allowed - no x-pens. Please be careful about water/food/etc spillage on the floor, keep area clean.**

#### BITCHES IN SEASON:

Bitches in season are eligible to compete but will be required to be kept separate from all other dogs and will be run at the end of their class/trial and must wear pants. If bringing a bitch in

season, you must inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

#### REFUNDS:

Any entries pulled prior to pre-entry closing will be refunded minus any Transaction fees. You must pull in writing (email or in person).

Any entries pulled after pre-entry closing will only be given a credit in the form of a voucher (minus a \$10 administrative fee per day) if there is an entry on the waitlist that can take your spot (\*refund issued minus admin fee)

You must pull in writing (email or in person) before 7 am on the day of the trial.

If you wish to re-enter another day with your voucher you will pay the current entry fee rate.

**TREAT VOUCHERS LIKE CASH. THEY WILL NOT BE REPLACED IF LOST.**

Entry fees will not be refunded/credited in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee or BHA.

Entry fees will not be refunded/credited in the event that a handler is ill or injured.

Entry fees will not be refunded/credited for bitches in season as they are eligible to compete.

Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. Any refund/credit of entry fees due to this will be made at our discretion.

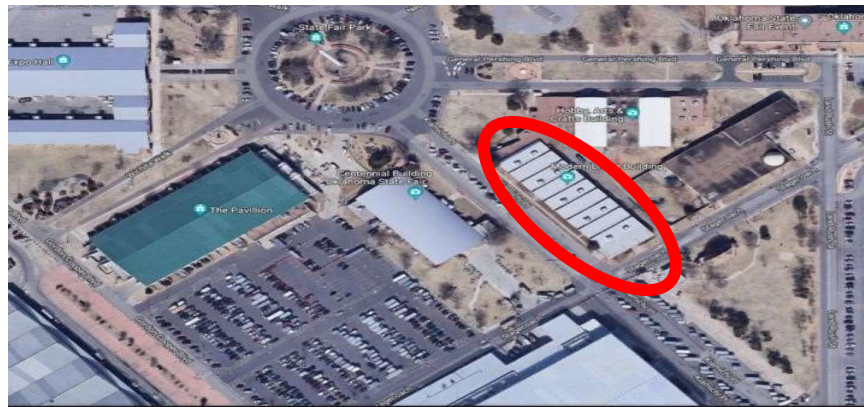

LOCAL HOSPITAL – Integris Baptist Hospital Directions – Exit fairgrounds from Gordon Cooper Blvd, go north on May Ave, turn West (left) on NW 10th, Take 1-44 E ramp toward Tulsa, go straight from 1-44 to OK-74N, take NW Expressway/OK-3A exit. Hospital is on the right.

#### CONFLICTS:

We would like to accommodate each and every conflict but that will more than likely be impossible, and you may have to make a choice. The running order for classes will be posted at each ring, each day. If you have a conflict, please ask the blind steward to put a "C" by your name. If you are not in at the ring when your blind is called, we will fill your space with someone that is present. When you are available to run, please check in and we will assign you to a new blind. We cannot guarantee you will run immediately upon checking in.

**We will not hold a class if you are not present by the time the class ends, you will not be able to run your dog in that class for that trial. There are two trials each day but a missed run in trial one cannot be run in trial two.**

#### AWARDS:

Qualifying ribbons will be awarded to all dogs with qualifying scores.

Placement ribbons will be awarded to first through fourth place in each of the three height divisions for Novice A, Open A, Senior A, Master A, and Master B classes.

HIC rosettes will be awarded for Novice A, Open A, Senior A, Master A, and Master B classes.

Placement ribbons will be awarded to first through fourth place across all height divisions for Novice B, Open B, and Senior B classes.

Special Champion High in Class (9 x 18, 5 Streamer) rosette and RHIC Champion (7 x 16, 3 Streamer) will be awarded. New Title rosettes, RATCH rosettes, Crazy 8 (Gold, Silver Bronze) medals will be available at event. Awards are self service and can be picked up from the secretary table. You will need to notify the secretary (sheet at table) of new titles. New Title Rosettes will be available for all regular classes.

Ribbons and labels must be taken on or before the last day of the trial (other than ribbons being personalized). Forgotten ribbons/labels will not be mailed.

Non-Standard Awards: Crazy 8's overall champion will be awarded an embroidered director chair and rosette. Winner will have the highest score from the event (6 Crazy 8 classes, do not need to compete in all 6 trials to be eligible). First tie breaker will be fastest time followed by reverse highest score by trial.

Additional special prizes may be awarded at the discretion of show committee to include prizes for volunteers.

Relic Rat Terriers and Icon Rat Terriers, in conjunction with their Top Dog supported entries, is offering a Rosette for the Top Rat Terrier in each of the classes (Novice, Open, Senior, Masters and Crazy 8's) on Saturday 29 June,

2024. The winner of each class may compete at either A or B level. The top dog will be determined first by qualification run, then by time as a total of both trials on Saturday. In the event of a tie there will be a coin flip.
