

Directions to workshop site:

The address is 655 N. Glenville Dr. #100 (main facility, lecture/discussion) and 675 N. Glenville Dr. #165 (practice judging), Richardson, TX (do not send entry forms to either address). Take US Hwy 75 (Central Expressway) to Arapahoe Road in Richardson, east to Glenville Drive, south about 1000' to the workshop site.

Note that the practice judging site is behind (west of) the main WAGD facility - see the satellite photo below for the precise location.



Hotels and Other Accommodations

There are a number of hotels in the vicinity of the workshop site. It is expected that participants needing hotel accommodations will have their favorites and will make their own arrangements.

"Working slot" includes all activities; "Audit" includes Mark's lecture and discussion only, but auditors may and are encouraged to observe and participate in discussion during all stages of the workshop.

Judge prospects (and licensed judges, at least once every three years) must purchase the working slot option and perform all stages for the workshop to count toward their judge certification or continuing education. Working slot entrants must also submit course designs to Mark by email before Wednesday December 28th (one complete single trial, Novice through Master with Crazy 8s between Open and Senior). **THIS IS A HARD DEADLINE.** A diagram of the ring will be provided upon receipt of the entry form and payment.

Because of the discounted price for this workshop, entrants will be expected to bring their own copies of the Barn Hunt rule books. Please also bring anything else you think you may need beyond this. Note-taking material is particularly important. Bring a chair if you can - the facility may or may not provide adequate chairs.

Dinner (pizza, sandwiches, or the like) will be provided to all participants on both days. There is also fast food available a short drive away if you want to get lunch to bring to the lecture/discussion session.
