ENTRY FEES

If entering online at secreterrier.com - \$15 per run Instinct, \$25 per run Novice, Open, \$30 per run Senior, Master, Crazy8 (additional fees may apply).

If mailing paper entries (see mailing address below) - \$15 per run Instinct, \$25 per run Novice, Open, \$30 per run Senior, Master, Crazy8

Entries are late if received after March 4, 2025 at 6:00 pm. LATE PAPER (mailed)

ENTRIES may be accepted until March 6, 2025, at 1:00 pm if trial has not filled.

NO DAY OF SHOW entries will be accepted. A maximum run value may require this club to limit entries accordingly, and may include a limit of 20 Crazy 8 runs per trial. **See page 3 for move ups, downs, or lateral move allowances.** Not all level move ups or downs may be possible. You are responsible for notifying the trial secretary in time to process paperwork.

Entry Submissions – Online entries are available through

secreterrier.com and fees will be taken at time of entry. Make sure to add your run selections to your cart and check out. Your entry status will be shown in your Secreterrier account. Note: If your entry status in Secreterrier is Awaiting Payment, your entry is not valid, you are **NOT** entered in this event. Please read the **Refunds** section on next page.

Paper entries with payment can be mailed and sent by regular USPS mail to the address below. No more than four dogs per envelope may be entered. We do not accept emailed entries. See mail-in address below.

NOTICE TO EXHIBITORS

Refunds:

Entry Fees **will not be refunded after closing date** or in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee. No entry fees will be refunded if the trials cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, weather, public emergency, act of a public enemy, or any other causes beyond the control of the Event Committee.

Refund of online entries that are accepted prior to the close date, may incur non-refundable fees of up to 3%. (Excludes waitlisted entries).

- Bring chairs and crates. Crating will be from your car. Your dog can be crated, outside under cover but space may be limited. Pop ups are allowed. Parking will be on grass.
- Possessing or training with personal, live quarry is not permitted on the show grounds at anytime. This also includes your place of lodging while attending this event.
- Dogs must be on a leash at all times except when in the ring. Leashes cannot be left dangling or dragging. For safety purposes, the use of Flexi leads or retractable type leashes are not allowed inside the building.
- Exhibitors are responsible for cleaning up after their dogs. Potty areas designated by the club include the entire property and all grassy areas.
- Exhibitors are responsible for being ready to go to the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class.
- Texas Rat Masters assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.

Directions to the Event – 178 Red Oak Lane, Trinity, TX 75862 (Do not send entries to event address. See Entry Submissions section)

From Trinity Texas on Highway 19 (N Robb Street), turn onto Hwy 94 (E Caroline Street) and cross the railroad tracks. Turn right on Hwy 356 (Emory Street). Road will curve to the left and become E Pegoda Rd (still Hwy 356). In about 4 miles, turn right on Marina Dr. Make the first right onto Rock Creek Dr. Look for the Rock Creek/River Point Subdivision sign on the left side of the gravel road. Road will curve around and when you come to the fork, turn left onto River Point Way. Turn right on Red Oak. We are on the right.

Tentative Start Times- Final confirmation attachment will have more information regarding class and estimated check in times. Facility will be open one hour prior to start time on Saturday and Sunday.

A General briefing will be held 10-15 minutes prior to the first dog running each day. Class level briefing for Instinct and Novice will be held before loading the first blind. Judges written briefing and a general briefing will be posted in predetermined areas.

Saturday and Sunday – First dog will run at 8:00 am.

Estimated check in times should be announced 2 days before the trial dates on Facebook and by email.

Planned Running Order

Saturday – T1 Instinct, Novice, T2 Novice, T1 Open, T2 Open, T1 Crazy 8, T1 Senior, T2 Senior, T1 Master, T2 Master

Sunday – T3 Master, T4 Master, T3 Senior, T4 Senior, T3 Crazy 8, T3 Open, T4 Open, T3 Instinct, T3 Novice, T4 Novice

Blind size is more than 150 sq ft. All Instinct through Senior blinds will hold no more than 5 teams. Master blinds will hold no more than 4 teams.

Height Divisions: Small, Dogs 15" & under; Medium, Dogs 15.1" to 22"; Large, Dogs over 22". Dogs are measured at the option of the judge.

BITCH IN SEASON - Bitches in season (BIS) may compete at Barn Hunt trials & fun tests. They will be run at the end of each class. BIS **must wear well-fitting pants/britches at all times** when not being pottied, including on the course. Owners of BIS should crate/confine their dogs away from traffic and other dogs, and potty away from other competitors. Please notify the trial secretary upon arrival so running order can be adjusted.

Facility rules – It is your responsibility to read and be familiar with BHA rules, which includes but not limited to facility grounds.

Entering and attending any Barn hunt Event at any time is done entirely at your own risk.

Spectating

Spectators allowed where space for observing is available. Spectator areas will be at the discretion of TRM.



Destroyed course materials - Please be aware that TRM is no longer able to absorb the cost of destroyed course materials. Destroyed course materials which include but not limited to bales, boards, mats, or misc. course equipment, may incur a replacement fee set by the club at the club's sole discretion. Bales that have been eliminated on, pulled apart/shredded to the extent it loses the shape, twine broken or pulled off (due to lack of control) are no longer useable and are considered destroyed. A **replacement fee of \$15 (per bale)** may be incurred. Replacement fee(s) must be paid before the end of the event. If paying by credit card, add \$5.00. See trial secretary regarding payments.

Additional Information:

All Barn Hunt Clubs are assigned a Maximum Run Value per day. Judges are also limited to 8 hours of judging per day. Entries are not guaranteed and will be accepted only up to judging limits. If the trial fills, a wait list will be maintained.

Questions about What Class to Enter?

Please refer to and review Part 14: Regular Classes section of the BHA Competitor Rule book.

Section 2: What Class to Enter. When sending in an entry prior to the Event, the Class entered depends on titles previously earned. Dogs cannot be entered in a class they are not yet eligible to enter. It is the competitor's responsibility to know the dog's eligibility. (TRM does not have access to that information and does not have knowledge where you last competed.) Per BHA, any dog entering a class they are not eligible to enter will have any and all qualifying scores removed for that class. (See Flow Chart on page 18 of Competitors Rule book.)

Section 3: Moving Up, Down, or Over during an Event

At this event, Competitors can move up (A to next level A) or over (A to B at the same level) trial to trial **if running order allows**, and time and/or judging limits are not exceeded. Dogs achieving RATM from Master A must move to Master B for RATCH and RATCHX and above.

Competitors can move down (A level title earned and move down to lower level B) day to day **if running order allows**. (Original entry fees will not be adjusted, credited, or refunded.)
