Check-in begins at 7:00 a.m. General Briefing at 7:45 a.m.
Judge's Class briefing at 8:15 a.m. for Instinct and Novice. First dog in the ring at 8:30 a.m.

Judge is limited to 8 hours of judging and a maximum run value, which will require this Club to limit entries accordingly.
Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits.
Confirmations will not be sent for late entries.

Move-ups/downs/lateral moves will be allowed from trial to trial only if you obtain a title at this event.
You need to decide if you want to either stay in that class and move to "B",
or move up to the next class in "A" or move down to a lower class in "B". You must do one of these.
Please see the Trial Secretary for the form and to assist with the process!
Be sure to check results and collect any ribbons by the end of each day.
Any ribbons left at the trial will not be mailed.

Awards

Placement ribbons will be awarded for 1st through 4th place in Novice, Open, Senior, and Master classes in each height division for the A Classes and with all heights combined for the B Classes. Qualifying ribbons will be awarded for all qualifiers in the classes, including instinct. New Title Rosettes will be awarded to those who qualify, excluding Instinct. High in Class rosettes will be awarded to fastest qualifying run in each class, excluding Instinct.

General Information and Policies

It is the responsibility of each competitor to read and understand the current Barn Hunt Association, LLC (BHA) Rules prior to participating in this event. <http://www.barnhunt.com/forms/barnhuntrules.pdf>.

Please note: A BHA registration number is required for a Trial! You can register your dog on line at <http://www.barnhunt.com>. BHA registration fee is \$32, and is a lifetime fee for that dog. There are no annual fees with BHA, and no membership fees for dog owners.

This premium may be updated due to changes or corrections before the Event.

Possessing or training with personal tubes and/or live rats is NOT permitted on the event grounds at any time.

Events will be held under cover. Dogs must be leashed or crated when not in the blind or ring. Crating is outside the barn or out of your car (you can park close to the Barn). Please pick up after your dog and dispose of waste in appropriate containers. Multiple potty areas are available.

Barn Hunt Grounds: Barn Hunt rules apply to any activities held in the ring and surrounding property at 2408 Owens Gin Rd. (includes any RV area, car parking and grassy areas). Barn Hunt area is handicapped accessible.

Blinds: 5 competitors per blind for Instinct, Novice, Open, Senior and Crazy 8s, 4 per blind for Master.

Leashes and collars: See the BHA Competitor Rulebook for specific information on what is allowed. Flexi-Leads are NOT allowed anywhere on event grounds.

Dog aggression: Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the event if justification is found by the judge and/or Event Committee. Entry fees will not be refunded.

Bitches in season: Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class. They must wear pants at all times (including on course) while not being pottied. They must be pottied in a designated area away from the other dogs. **The trial secretary must be notified prior to or upon arrival. Failure to do so will result in a disqualification and dismissal from the event.** Entry fees for bitches that come into season will be refunded, if you wish to withdraw, only until the closing date of March 18, 2024.

Lunch: There are numerous food places close to the trial site.

Videotaping and photography: Is allowed and encouraged!

Volunteers: Are appreciated and needed!

Sportsmanship: All competitors/handlers and spectators are expected to follow the rules of the BHA and demonstrate good sportsmanship. Please do not discuss hide placement or any details of a dog's performance that may provide information or clues to other handlers or may be overheard. Please be cognizant of teams competing in the ring and avoid loud or disruptive distractions.

Crating: Dogs must be leashed or crated when not actively working, and never tied out/left attached to anything other than a human. Crating space will be outside on the grounds or in your vehicles. Be sure to bring anything you may need to keep your dog comfortable and safe.

Payment and entry information: Entries will NOT be accepted without signatures and payment (cash or check or money order). Owners are responsible for entry errors. Please write clearly and proof your entry. BHA will not make corrections once results are submitted. Incomplete forms, nonpayment, and returned checks are invalid entries. There is a \$50.00 fee for all returned checks. Entries accepted on a first come/first served basis.

Refunds are ONLY allowed if requested before the closing date of April 14, 2025. No refunds issued after April 14, 2025. No refunds for "girls in season" ... they are able to complete their runs but must wear panties and will run last in class.

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, injured, excused, or barred from competition by action of the Event Committee.

North Georgia Kennel Club, and its agents, volunteers, etc., will assume no responsibilities for any loss, damage or injury sustained by participants or spectators, or to any of their dogs or property and further assumes no responsibility for injury to children. North Georgia Kennel Club reserves the right to decline entries for cause and may remove any dog on account of dog or human aggression. No one shall have any recourse or claim against North Georgia Kennel Club, or any agent thereof.

Certification of Agreement upon Registration or Entry of Dog

I certify that I am the actual owner of the dog(s), or that I am the duly authorized agent of the actual owner whose name I have entered.
