Barn Hunt is open to all breeds and mixed breeds of all sizes. Dogs must be 6 months of age or older to compete. Dogs must have a Barn Hunt number to enter. For a complete copy of the rules or to register a dog, go to www.barnhunt.com.

At all times, the safety of the dogs, handlers, and rats, is to be of paramount importance. At will be humanely handled and safely confined in aerated PVC tubes. Barn Hunt is not intended to harm or kill rats.

Facility doors open 1 hour before trial starts. Doors close 1 hour after last dog runs.

Notice to Exhibitors

🐾 How to submit your entry (No Emailed entries will be accepted)

- **Online** - www.secreterrier.com (make a user account using the same email as your BHA profile account)
- **Mail In**
 - Fill out entry form from this trial premium.
 - OR use the “Create/Modify Mail-in Entry Form” link from the BHA website.
 - You must still print and sign this form before mailing.
 - Mail either form to Canine Adventures PO BOX 265, Farmington, MI 48332.
 - Must include Check payable to Canine Adventures.
 - Entries MUST be signed to be valid.
- ***Entries will not be accepted via email.***

- 🐾 **Invalid Entries** – Entries are not valid for the following reasons: SCREENSHOTS, unsigned, no payment, incorrect payment, wrong information, incomplete information, to name a few. Complete list of reasons can be found in the Rules on www.barnhunt.com. Invalid entries will be notified and not processed until all information has been completed.

- 🐾 **Payment** will be processed when entry is received, i.e.: cashing of checks, run payment, etc.

- **Non-Sufficient Funds** – All payments returned with NSF will be subject to a \$50 fee.
- **Checks** are made payable to Canine Adventures. Accepted with mail-in entry form only.
- **Credit Cards** can be accepted through online registration using Secreterrier.com. Processing fees will be added.

- **DOS Entry fees** must be paid with cash or credit card only. Processing fees will be added.
- 🐾 **Entries/closing dates**
 - **Entries** – Mail-in entries will be considered “on time” if postmarked by the entry closing date posted in the premium. Online entries will be accepted until the posted time on Secreterrier.
 - **Day of Show (DOS)** – Entries presented to the trial secretary on the day of a trial event during registration/check in. Requires additional fees.
 - **Late Entries** – Accepted through Secreterrier.com only. Requires additional fees. Late entries are not guaranteed to be sent a final confirmation email with counts.
 - **Entries received before the open date will not be considered.**
- 🐾 **Confirmations** – Confirmations will go out in the form of email from notifications@Secreterrier.com. Please print your email address clearly.
- 🐾 **Rules** - It is the handler’s responsibility to read and understand the rules in the **Competitors Rule Book**. Rule books can be found on the Barn Hunt Association website.
- 🐾 Dogs may enter both **Instinct and Novice** in the same trial until the dog has earned the RATN title.
- 🐾 **Bitches in season** – BIS may compete at Barn Hunt Trials. They must wear pants and be kept separate from other dogs. BIS will run at the end of their class. Designated walking and crating area will be assigned or must crate out of vehicle. Please inform the trial secretary when you arrive for additional information.
- 🐾 **Height Divisions** – Small (15” and under), Medium (15.1” to 22”), and Large (22.1” and over). Placements are based on height, please have an accurate height recorded.
- 🐾 **Dog Aggression** – Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the trial if justification found to do so by the judge and/or trial committee.
- 🐾 **Cancellation Policy** – Every attempt will be made to hold this event as scheduled. In the event of an “Act of God” such as fire, flood, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.
- 🐾 **Withdrawals/Refunds**
 - **Before closing date** - If a competitor withdraws before the closing date, a refund will be issued, less any processing fees, within 5 days after the trial.
 - **After closing date** - Refunds may be given after the closing date, *only* if a wait list has been started and the runs are replaced by a dog on the wait list. If a refund is warranted, one will be issued, less any processing fees, within 5 days after the trial.
 - **Withdrawal due to dog injury or illness** - Refunds may only be given for dog illness or dog injury *with* a note from a Veterinarian. Notes must be presented before trial begins. A refund will be issued, less any processing fees, within 5 days after the trial.
- 🐾 **Waitlist** – When maximum run limit or maximum time limit is reached, a wait list may be started. All waitlist movement will end 2 days before the trial. Any runs remaining on the waitlist will be offered a credit to Secreterrier account or a refund check.
- 🐾 **Move ups** – will be allowed on appropriate days. This will be determined by the running order. A move up (up or lateral) will be granted to those who complete a title. No move downs allowed on day of event.
- 🐾 **Crating area** – Please check in with the trial secretary for the designated crating area information. There is plenty of indoor crating at this trial. You will need to bring a tarp to place under your crate, chairs, and belongings. You may also crate out of your car or outdoors.

- 🐾 Dogs must be under control while on trial grounds. All dogs must be on a short leash or crated at all times unless actively working. RETRACTABLE LEASHES ARE NOT PERMITTED ON PREMISIS.
- 🐾 **Smoking/Vaping** is not permitted on trial grounds.
- 🐾 **Ribbons and Awards** – Brown flat ribbons will be awarded for all regular classes and Line Drive qualifying runs. Instinct Title ribbons are brown flat ribbons and will be awarded for a dogs 1st qualifying Instinct run. Special brown flat ribbons will be awarded to dogs with a positive score in Crazy 8s. Placement ribbons will be awarded for 1st thru 4th place. High in Class rosettes will be awarded to all A level classes and the Champion Level. New Title awards will be given to dogs with 3 qualifiers in Novice A, Open A, and Senior A; dogs with 5 qualifiers in Master A; and dogs with 10 qualifiers in Novice B, Open B, Senior B, and Master B/Champion Levels. New Title awards for regular classes will be rosettes, larger rosette ribbons will be awarded for a RATCH. New Title awards for Crazy 8s will be neck medallions. Specialty awards may be offered at this event.
- 🐾 **Ribbon Presentation** – Results and ribbons will be displayed on the ribbon display table to be picked up. Results take a minimum of 30 minutes to process. Please allow the secretary sufficient time to input and calculate results. If you find yourself waiting around for your ribbons, help out in the ring while you wait. Results are tabulated at the end of the 2nd trial of each class. Any ribbons not picked up at the end of the last day will be returned to stock.
- 🐾 **Trial Grounds** – This trial will be held on private property. This is an indoor event. Giant heated pull barn but not climate controlled. In warmer months, natural ground surface aids in keeping building cool. Please dress accordingly. Trial grounds includes pull barn, and parking area. There will be a porta potty onsite.
- 🐾 **Parking** is free for this event.
- 🐾 **Food** – There are no restaurants nearby. We will be hosting a potluck lunch or a \$5 donation option. All donations will be donated to For The Sake of Being Humane Rescue in Fennville, MI.
- 🐾 **Ring** – Dirt floor covered by matting, combination of 4' black wire fence panels, 4' lattice fence panels. Indoors.
- 🐾 **Blind** – Indoors, minimum 10' x 20' area, maximum 6 dogs in blind.
- 🐾 **Directions to 11575 Cobb Rd, Delton, MI 49046.** We recommend using Google maps.
