AWARDS:

Qualifying ribbons will be awarded for all A & B classes, and Crazy 8s. There is also a special qualifying ribbon for REMX runs.

1st-4th placement ribbons will be awarded for all A & B classes. All A class placements will be by height (S,M,L) as will Master B. There are no placement ribbons for Crazy 8s.

High in Class ribbons will be awarded to the overall fastest dog for each A class and for Master B. This excludes Instinct and Crazy 8s.

New Title ribbons are available for all levels, including Instinct and Crazy 8s.

Perfect Weekend Rosettes – this is for Master entrants only and they must have been entered in at least two days/events

REMX Title Rosette – for those earning any of their REMX titles.

Judge's Choice Rosette – awarded at the Judge's discretion; criteria can be most entertaining team, team that tried the hardest, funniest team, etc. You do not need to qualify in classes to earn this ribbon. Winner must be entered in at least two days/events

Notice:

All dogs must be on a short leash and under control while on trial grounds. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited-slip martingale collars are allowed. Single-piece slip collars/leads are allowed. Harnesses, except for head-halter types, are allowed. Dogs **MUST** run naked, without a collar/harness.
