Late Entries may be accepted until January 15, 2026 at 12:00pm if the trial has not filled. **NO DAY OF SHOW** entries will be accepted. Late entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

Exhibitors can only enter classes they are eligible for at the time of entry.

MOVE UPS: Not all level move ups or downs may be possible. You are responsible for notifying the trial secretary in time to process paperwork. No move ups can be taken on Sunday due to run order.

REFUNDS: Entry Fees for withdrawal will not be refunded after the closing date or in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee. No entry fees will be refunded if the trials cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the Event Committee.

WAITLIST: A waitlist will be maintained. Entrants who withdraw after 1/3/2026 and before 1/15/2026 will receive a refund if and only if there is an entrant on the waitlist who can take their place. Please notify the Secretary as soon as possible if you are canceling.

Double-entry per trial will not be allowed.

Blind size is 200 sq ft. with no more than 6 competitors per blind for Instinct, Novice, and Open; 5 for Senior, Crazy 8s, and Master.

LOCATION

Trial ring will be in Building "A". This is the first building as you come into our grounds. The entire CATC property is considered Barn Hunt Grounds during the trial. All dogs must be on lead or crated at all times unless actively working in the ring. For safety purposes, the use of Flexi leads or retractable type leashes are not allowed inside the building.

FLOORING

Flooring is foam matting. The ring area will have a tarp cover over the flooring.

CRATING

Limited crating space will be available in Building A with priority given to committee members and volunteers.

FOOD

Lunch will be available for purchase. There are also various fast food restaurants within 1 mile of the facility, Alum Creek Rd. and 270.

AWARDS

Rosettes will be offered for high in class and new titles. Ribbons will be offered for placements. Special awards may be offered.

NOTICE TO EXHIBITORS

Exhibitors are responsible for cleaning up after their dogs. Potty areas designated by the club include the grassy area between the two buildings.

Exhibitors are responsible for being ready to go into the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class.

Columbus All-Breed Training Club assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.

BITCH IN SEASON - Bitches in season (BIS) MAY compete at Barn Hunt trials & fun tests. They will be run at the end of each class. BIS must wear well-fitting pants/britches at all times when not being pottied, including on the course. Owners of BIS should crate/confine their dogs away from traffic and other dogs, and potty in the designated BIS potty area. Please notify the trial secretary upon arrival so the running order can be adjusted.
