## **BARN HUNT TRIAL**

**4 Trials - 2 Trials Each Day**

**Sunday and Monday, October 4<sup>th</sup> and 5<sup>th</sup> , 2026**

**SAMOYED BREED Early Entries Open 5/1/26, Entries Close 8/1/26**

**All Breed/Mixed Breed Entries Open 8/1/26, Entries Close 9/15/26**

**Judge: Penny Link, BHAI-196A, Springfield, TN**

**Judges are limited to 8 hours of judging and a maximum run value of 240 MRV, which will require this club to limit entries accordingly. Priority and early entries will go to Samoyed breed entries. This event is concurrent with the Samoyed Club of America Nationals in Kingsport, TN, but does not overlap SCA National Week events.**

**Permission has been granted by the Barn Hunt Association, LLC for holding these Barn Hunt Trials under BHA Rules and Regulations.**

### **Directions to the Event 131 CW Galloway Road, Jonesborough, TN**

**From I-26, take Exit 13 (Gray), follow TN-75 South for 4 miles, turn left onto Douglas Chapel Rd., then make an immediate right turn onto CW Galloway Rd. and follow to the end of the road. Signs will be posted on the road.**

**Covid Plan = Masks are optional**

**Trial Site:** The trial grounds run from the black board fence starting at the red double gates to the parking lot field behind the gray metal building, and from the black board fence to the left of the driveway over to the small red metal building and kennel in the lower level of the gray brick building. Included is the field accessed through the double red gates at the front of the property, the RV parking/camping area. Not included is the fenced in area behind the barn.

**Parking:** Go straight down the asphalt drive, (it will turn into gravel) and go past the red wooden barn and the gray metal building. Parking is behind the gray metal building.

**Crating:** You may crate out of your vehicles. There is little shade, so bring your own pop-ups, shade screens, and fans. Please make sure your crate is safe and secure as the dogs may be extremely excited. Owners of excessively barking dogs will be asked to quiet their dogs, stay with their dogs, and/ or cover the crates.

#### **Run Order**

**Sunday:** Masters, Seniors, Crazy 8s, Instinct, Novice, Open. **Monday:** Masters, Seniors, Instinct, Novice, Open, Crazy 8s. Same-day move ups from Novice to Open only.

#### **Lunch will be at the Judge's discretion.**

Judges of Record and Event Officials dogs may be judged prior to the event starting or as the first dogs of the event.

**Entries will be accepted in the following ways:**

1. **Register and pay through Secreterrier.com** fees will apply as described on website.
2. Entries that die on the wait list will be refunded in full by the end of the last day of the trial if the run cannot be accommodated in the schedule less 3% to cover credit card fees. All entries cancelled by the competitor will be refunded less 3% to cover credit card fees.
3. Paper/hardcopy entries to Danielle Lee, PO Box 8144, Gray, TN 37615. Entries are first come, first served, so Online entries are encouraged/preferred.

**Entries** made without fees, barn hunt number, height or waivers signed will not be accepted. Owners are responsible for errors in making out entry forms, or whoever may have filled out the form and made such errors. Please check your confirmation carefully and make sure your information has been recorded correctly, especially your dog's Barn Hunt number.

**Entry fees** will be refunded after the closing date if a vet note is received, and runs can be filled by a waiting list.

**Entry fees** will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

**NADM Barn Hunt** reserves the right to refuse any entry for any reason. You will be notified by email and your entry fee will be returned.

**BITCH IN SEASON:** Bitches in season (**BIS**), **MAY** compete at Barn Hunt trials & fun tests. They will be run at the end of each class. BIS must always wear pants/britches, including on the course, except when being pottied. Owners of BIS will crate/confine their dogs away from traffic and other dogs, and potty away from other competitors. The club will designate an area for BIS. The owner will post Dog In Season sign on their crate. Owners of BIS should make their condition known to the Trial Secretary prior to arrival, if possible. Entry fees for Bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded.

**ENTRIES:** Any dog of any breed or mix breed that is, 6 months of age or older, may participate in Barn Hunt Trials. The only limitation is that the dog must be able to fit through an 18" wide by 22" high "tunnel" made of straw/hay bales and have usable vision.

**Height divisions:** **Small Dogs** 15" and under, **Medium Dogs** 15.1 to 22", **Large Dogs** over 22". Dogs are measured at the option of the Judge.

**The Blind** outdoor is across from the rings, located in a 10x20 tent.

Exhibitors are responsible for being ready to go from the staging area and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class.

**There will be a short lunch break at the judge's discretion.**

**AWARDS:** Ribbons will be awarded to those who obtain a Ribbon at Our Trial. Qualifying ribbons will be awarded to all qualifiers in all classes. New Title Ribbons, Placement 1<sup>st</sup> through 4<sup>th</sup>, High in Class, and the following Crazy 8 Titles: Bronze, Silver, Gold, Platinum, DBL Bronze, DBL Silver, DBL Gold, Double Platinum, Bonus and Super bonus.

**SPECIAL SAMOYED BREED AWARDS:**

The SCA 2026 National will provide special sponsored prizes for Samoyeds during this two-day trial.

The fastest qualifying Samoyed at each level (Instinct, Novice, Open, Senior, Masters A, Masters B) per trial (four trials total) will receive a commemorative rosette, as well as a prize.

Trial One: Rosette and commemorative tray

Trial Two: Rosette and embroidered towel

Trial Three: Rosette and custom tumbler

Trial Four: Rosette and custom lead

All Samoyeds who receive a qualifying run will receive a commemorative surprise to celebrate the occasion (one per samoyed per day). Additionally, the Samoyed who finds the most rats during each Crazy8 round will receive a prize basket donated by Courtney Bouthiller of Lady's Legacy Samoyeds.

Breakfast refreshments, and light afternoon snacks will be provided by the SCA National

**Volunteers:** are always welcome and appreciated. Volunteers are the backbone of any trial. We will accommodate volunteers running in the classes for which they are volunteering. We will also train you for the jobs for which we need volunteers. You will learn a lot by watching the dogs run.

**Exhibitors are responsible for cleaning up after their dogs or will be charged with misconduct.**

**Do not use my neighbor's yards or fields on the other side of my fences to potty or walk your dogs. Do not turn your dog's loose in the Agility/Pool field/Agility ring or elsewhere.**

**Smoking is ONLY allowed in your vehicle. Disposing of cigarette butts on the Farm grounds is an automatic dismissal & No Refund.**

Possessing or training with personal, live quarry is not permitted on the trial grounds at any time.
