Please pick up ribbons at the score table once your class is scored. No awards will be mailed.

New Titles: A special gift from the club is offered for Instinct – Senior and Crazy 8s. Rosettes are offered for Master and Championship titles.

Notice to Exhibitors:

- Refunds will be issued 7 days after the event.
- No refunds will be made for cancellations after the closing date or entries which are cancelled, absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to Liz Carter.
