GENERAL INFORMATION AND TRIAL RULES

REGISTRATION:

Friday March 13th at 8:00 pm that day to closing Friday March 27th at 8:00 pm or when the trials are full.

Instinct: \$20.00 Novice: \$32.00 Open: \$32.00 Senior: \$32.00 Masters: \$32.00 Crazy 8's: \$32.00

Payments will go through DogShow.ca. Payments are due within 48 hours of each entry being approved, regardless if you have others sitting on the waitlist. Any unpaid entries after this time will be forfeited and opened up to the wait list should there be one.

Friday March 27th (by 8:00 pm) is the last date and time to pull from a trial with a refund (minus service charge).

SCHEDULE:

Check in: Secretary Desk inside main front double doors of the horse barn – please check in without your dog due to space constraints. Opens at 12:30 pm until 1:30 pm on Friday April 10th, 2026 and at 7:45 am until 8:30 am on both Saturday April 11th and Sunday April 12th, 2026.

General Briefing: Approximately 1:45 pm on Friday April 10th, 2026 and at approximately 8:15 am on Saturday April 11th & Sunday April 12th, 2026.

Classes Offered & Tentative Running Order each day:

Friday: Instinct, Novice Trial 1, Novice Trial 2, Open Trial 1, Open Trial 2, Crazy 8's Trial 1

Saturday: Instinct, Novice Trial 3, Novice Trial 4, Open Trial 3, Open Trial 4, Crazy 8's Trial 3, Senior Trial 3, Senior Trial 4, Masters Trial 3, Masters Trial 4

Sunday: Instinct, Novice Trial 5, Novice Trial 6, Open Trial 5, Open Trial 6, Crazy 8's Trial 5, Senior Trial 5, Senior Trial 6, Masters Trial 5, Masters Trial 6

Move-ups are permitted all 3 days.

'B' CLASSES: Offered. If you have a RATM title then you are working toward RATCH and MUST be in the B Class (Championship).

Each day: Small to Tall dogs with accommodations made for handlers with multiple dogs. Judge will break for lunch at their own discretion.

Dogs may enter both the Instinct class and Novice class in the same Trial until the dog has earned the RATN title and then they can't enter the Instinct class.

CONFIRMATION OF ENTRY: The receipt of entries will be confirmed once your runs have been approved for those providing a return e-mail address on their form. Confirmations are sent via email. If you don't receive an email confirmation **before** the closing date e-mail the Trial Secretary ASAP!

VALIDATION OF ENTRIES: Entries must be complete, accurate and legible with entry fees, signed WAIVER AND INDEMNITY included. Entries submitted without this agreement filled in and signed will be refused participation in the Trial. ***Note that payment is due for each approved entry within 48 hours, regardless if you have any other entries sitting on the waitlist. Otherwise the entry will be forfeited***

REFUND OF ENTRY FEES: Entry fees (excluding the service charges), are refundable provided we receive your entry withdrawal notice before entry closing. Entry fees will not be refunded after the closing date in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Exceptions for injured/ill dogs with veterinarian proof may be considered for a refund (excluding the service charges). No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, any act of God, public emergency, act of a public enemy, or any other causes beyond the control of the Organizing Committee.

MOVE UPS: Dogs earning a title in one trial may be moved up to the next level in the next trial, at the discretion of the handler. Move-ups will be accepted until 30 minutes before the start of each Trial. **You MUST complete the Move-Up Form** available at the secretary's table.

AWARDS: Q ribbons will be awarded for all qualifiers in the regular classes (A & B). Dogs that earn a Barn Hunt title of RATN or higher will receive a title rosette.

Placement ribbons will be awarded for 1st through 4th place in all classes in each height division in "A" classes and in "B" classes (as per the rules).

High In Class ribbons will be offered for the fastest qualifying dog in "A" & "B" classes.

Additionally – The B-RAT Pack gives out the "Speedy Rat" award to the fastest qualifying run for each level (Instinct/ Novice/ Open/ Senior/ Masters) and the "Limping Turtle" award to the slowest qualifying run for each level (Instinct/ Novice/ Open/ Senior/ Masters) for each trial.

TRIAL SITE: The Trials will be held inside an indoor horse arena, but it is not heated so please dress accordingly. Two Port-a-Pottys will be on site – they are not wheelchair accessible. Bring water, shelter, etc. for you and your dogs (crate, x-pen). Trials will run rain, shine or snow. Note that crating will have to be done out of your vehicle so please also dress your dog accordingly for weather.

PARKING: There is a large gravel parking lot adjacent to the left side of the indoor horse arena. Please do not park at the front of the horse barn nor on the right side.

BITCHES IN SEASON (BIS): May run in Barn Hunt trials, but MUST wear panties. You MUST inform the Trial Secretary prior to the trial and inform all exhibitors at the judge's briefing that you are

bringing a BIS. Failure to do so is grounds for disqualification and dismissal. Owners of BIS will crate/confine their dogs in the Club's separate designated area for BIS and will only walk and potty their dog in that designated area.

NOTICE TO EXHIBITORS

VERY IMPORTANT! YOU MUST BE AWARE OF ALL BARN HUNT

RULES: www.barnhunt.com

- All dogs **must be under control & on a short leash** while on grounds, except when competing in the ring.
- Use approved BHA collars. Dogs MUST run “naked” in the ring. PRONGS are allowed with quick detach and COVERED. See BHA rules for specifics.
- Dog Aggression: Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the Trial and the grounds if justification is found to do so by the judge and/or Trial Committee. In such case, no refund of any fees paid will be made.
- Loud/Disruptive dogs: Please keep barking to a minimum so as not to disturb working dogs and/or people who live on the property.
- Exhibitors are responsible for being ready to go to the blind area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class/blind.

- Exhibitors and spectators are required to respect all signs posted on the property.
- Handlers MUST clean up after their dogs. There will be baggies available and a garbage bin for disposal.
- This Trial is being held on private property and we are here at the pleasure of our hosts.
- Any disruptive/dangerous or discriminatory behaviour will be cause to be asked to leave the property immediately without refund as determined by the property owners and/or members of the B-RAT PACK Board of Directors.
- The B-RAT Pack Club will use care and diligence for the safety and welfare of the dogs, the exhibitors, the spectators and the quarry, but will not be responsible in the event of any accident to dogs, exhibitors, spectators or quarry.
- **There is NO SMOKING on the grounds anywhere.** The use of illegal drugs and/or alcohol and or smoking/vaping of any kind including legal marihuana will NOT be permitted at the Barn Hunt events held at Iverstone Equestrian Park. This includes within your vehicle while on the grounds. You will be excused immediately from the grounds without refund.
- No flexi leashes are permitted anywhere on the property.

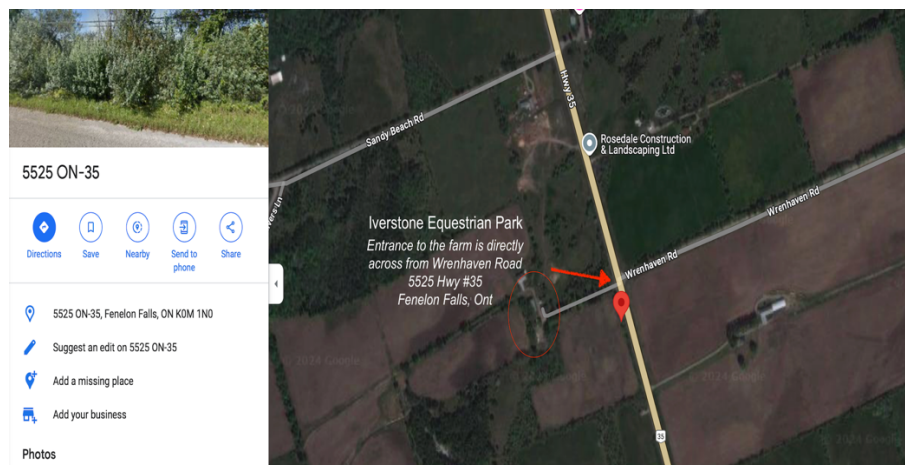
