A working spot includes all activities, Judge prospects (and licensed judges, at least once every 3 years) must attend a workshop with a working spot and perform all stages for the workshop to count toward their judge certification or continuing education. Working spot entrants must also submit course designs to Brydon by email brydon@barnhunt.com before Wednesday May 20th, 2026(one complete single trial, Novice through Master with Crazy 8's between Open and Senior). A diagram of the ring will be provided upon receipt of the entry form and payment.

An Audit spot includes lecture only. However, auditors are encouraged to observe and participate in discussion during all stages of the workshop.

Dogs will not be allowed to be crated or present in the pole barn lecture room.

Please bring copies of the Barn Hunt Rule Books and anything else you think you may need. Note taking materials are particularly important. You may also want to bring a chair. We have some chairs available, but you may be more comfortable in your own chair.

We will provide a light breakfast and lunch each day. Beverage will be available. There is a coffee shop with breakfast and lunch in town less than 5 mins away.
