This event is limited to the Mudi Specialty and its workers. Judging will be limited to 4 hours of judging and a maximum run value, which will require this club to limit entries accordingly. No refunds after closing date of July 27, 2026.

Doors open 1 hour before the start time of 6PM. Briefings are held 30 minutes prior to start and Instinct and Novice briefings are held 10 minutes before the start of each class. Facility will close 1 hour after the event.

Classes are held concurrent ie Instinct, Novice 1 then Novice 2 then Open 1 -2 then C8 (1) Senior Master etc.

The pole building is heated with rubber matted floor. There is plenty of parking in a grass field.

This is a working horse farm so horses and horse pool is off limits. Our blind in a 10x20 area with plenty of room. Max number of dogs will not exceed 6.
