Friday/Saturday run order: Instinct 1, Novice 1&2, Open 1&2, Crazy 8s 1&2, Senior 1&2, Master 1&2

Sunday run order: Master 1&2, Senior 1&2, Crazy 8s 1&2, Instinct 1, Novice 1&2, Open 1&2

Exhibitors can only enter classes they are eligible for at the time of entry.

Double entry per trial is NOT available for this event.

Entry Fees: Instinct \$10, Novice \$25, Open \$25, Senior \$30, Master \$30, Crazy 8s \$30

Late/Day of Show: Instinct \$15, Novice \$25, Open \$30, Senior \$35, Master \$35, Crazy 8s \$35
(Late and/or Day of Show entries are not guaranteed entry and will be accepted only up to judging
limits. Confirmations will not be sent for late entries.)

Judges are limited to 8 hours of judging and a maximum run value, which will require this Club to limit
entries accordingly. Any Judge of Record at this event may be used in any ring.

GENERAL INFORMATION AND POLICIES

It is the responsibility of each competitor to read, understand, and follow the current Barn Hunt Association, LLC (BHA) Rules before participating in this event. Rules can be found at <http://www.barnhunt.com> . Submitting your entry via www.secreterrier.com indicates that you have read the rules.

Dogs must be individually registered with the Barn Hunt Association to enter this trial.

Possessing or training with personal tubes and/or live rats is NOT permitted on the event grounds at any time.

Facility Hours: NADM opens at 7:00am each day. The facility will close one hour after the last class ends each day.

Trial Hours: Day of Show entries are accepted from 8:00am to 8:30am each day, if limits are not reached with pre-entries. Check in begins at 8:15am and General Briefing begins at 8:45am, and first dog in the ring at 9:00am each day. Exhibitors are responsible for being ready to go from the staging area and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class.

Lunch will be at the Judge's Discretion

Judges of Record and Event Officials dogs may be judged prior to the event starting or as the first dogs of the event.

Move Ups: Move ups/downs/lateral moves and class changes will be accepted same day and between days every day and between trials as the class order allows. **Please note:** only the **Novice** class will offer move-ups on Sunday.

Entry Method: Electronic entry only via www.secreterrier.com . Payment is made through Secreterrier and may include processing fees described on the site. No mailed or paper entries will be accepted. NADM Barn Hunt reserves the right to refuse any entry for any reason. You will be notified by email and your entry fee will be returned.

Blind: Blind is 10'x20' shed located 15' from the ring. Master blinds will have four dogs, all other classes will have five dogs per blind, unless to accommodate lower levels for time, a sixth dog may be added.

Trial Site: The trial grounds run from the black board fence starting at the red double gates to the parking lot field behind the gray metal building, and from the black board fence to the left of the driveway over to the small red metal building and kennel in the lower level of the gray brick building. Included is the field accessed through the double red gates at the front of the property, the RV parking/camping area. Not included is the fenced in area behind the barn.

Parking: Go straight down the asphalt drive, (it will turn into gravel) and go past the red wooden barn and the gray metal building. Parking is behind the gray metal building.

Crating: You may crate out of your vehicles. There is little shade, so bring your own pop-ups, shade screens, and fans. Please make sure your crate is safe and secure as the dogs may be extremely excited. Owners of excessively barking dogs will be asked to quiet their dogs, stay with their dogs, and/or cover the crates.

Use designated potty areas. Do not use neighbor's yards or fields on the other sides of the fenced areas to potty or walk your dogs. Do not turn your dogs loose in the Agility/Pool Field/Agility Ring or elsewhere.

There will be a \$5 fee for any soiled bales of straw.

You will be asked to leave without a refund if you fail to pick up after your dog, no exceptions!

Dogs must be on a leash or always crated when not competing.

Smoking is ONLY allowed in your vehicle. Disposing of cigarette butts on the Farm grounds is an **automatic dismissal & No Refund.**

Bitches in Season: May compete at Barn Hunt Trials & Fun Tests. They will be run at the end of each class. BIS must always wear pants/britches, including on the course, except when being pottied in the BIS-designated potty area. Owners of BIS must always crate/confine their dogs away from traffic and other dogs, and potty away from other competitors in the designated area. Owners of BIS should make their condition known to the Trial Secretary prior to arrival, if possible. Entry fees for bitches that come into season will be refunded until closing date of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded.

Refunds: Refunds are ONLY allowed if requested before the closing date (all refunds will be less the nonrefundable Secreterrier and credit card fees). After that date, refunds will only be issued if runs can be filled from the wait list. Entry fees will not be refunded if the event cannot open or be completed due to circumstances beyond the control of the event committee (ie, act of God, riots, etc). Entry fees will not be refunded if a dog is absent, disqualified, sick, excused, or barred from competition by the Event Committee.

Wait List: Wait list will remain open until the end of the trial. After that, all waitlisted entries will be refunded.

Awards/Rosettes: will be offered at this event. Qualifying ribbons will be awarded to all qualifiers in all classes. New Title Ribbons, Placement 1st through 4th, High in Class, and the following Crazy 8 Titles: Bronze, Silver, Gold, Platinum, Platinum Bronze, Platinum Silver, Platinum Gold, Bonus, and Super bonus.

Volunteers: are always welcome and appreciated. Volunteers are the backbone of any trial. We will accommodate volunteers running in the classes for which they are volunteering. We will also train you for the jobs for which we need volunteers. You will learn a lot by watching the dogs run. No experience necessary! All volunteers can enter into a drawing for NADM Barn Hunt credits that may be used at a future trial.
