Sunnyside Dog Sports may utilize load balancing or split judging to help with trial efficiency. Any Judge of Record at this Event may be used in any ring. Qualifying scores will show the Judge who designed the Course.

Sunnyside is offering double-entry per Trial. Examples: Master A or B + Senior B; Open A + Novice B. Exhibitors can only enter classes they are eligible for at the time of entry, please handwrite on your entry form what extra entry you want, and add in the fee.

**Open to all breeds and mixed breeds registered with the Barn Hunt Association.**

**Outside possibly on grass, 10x20 blinds within 20 feet of the rings.**

**Ribbons for qualifying scores all A&B classes, 1st - 4th height placement.**

**Rosettes for HIC, HICB and new A&B titles in Novice, Open, Senior, Master.**

**Medals awarded for Crazy 8's Titles, Clean, Bonus, and Super-Bonus runs.**

**Ribbons and awards are available for each class after the results are posted.**

Identify yourself to the Chair, and the Secretary.**
