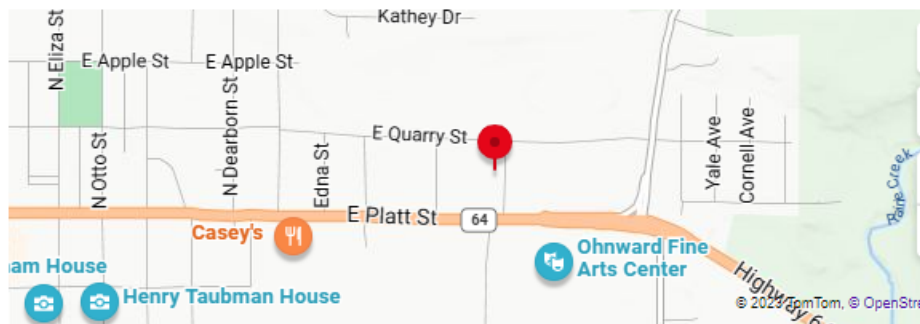

WORKERS TAKE NOTE:

We need volunteers to help keep the trial running. If you have some time to help, please let us know. If you work a class you

will get an entry into the worker raffle. Please give us three blinds of your time: Work a blind, potty your dog the next, run your dog the third.

EXHIBITOR INFORMATION:

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50.00 fee for all returned checks.

Dogs may enter both the Instinct test and Novice class in the same trial until the dog has earned the RATN title, after which they can no longer enter the Instinct test. Dogs earning a title in Trial 1 on Friday, Saturday or Sunday may be moved up, down, or laterally for Trial 2. Move-ups will be accepted each day for one-half (1/2) hour following the conclusion of the class. Move-up forms will be available at the Trial Secretary's table.

All dogs must be on a short leash, under control and attached to a human while outside of their crate on trial grounds. Approved collars include flat snap or buckle collars of solid construction and covered, quick release prong collars. Leather, cloth, or nylon leads are allowed. Limited slip martingale collars are allowed. Single piece slip collars/ leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Collars/harnesses which can be easily and quickly removed and replaced are strongly encouraged. Please bring a secure crate for your dog to relax in during times when they are not in the ring or are left unattended.

There is no smoking in the facility or on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle also. Dog exercise areas will be marked, please pick up after your dog and dispose of waste in appropriate containers outside the building.



Dogs are required to have a Barn Hunt Registration number to show in Barn Hunt events. Register your dog online at www.barnhunt.com

The run order and further scheduling details will be emailed to all competitors after the trial closes and the actual number of entries in each class is known. The Trial Committee reserves the right to change run order based on entries. Any judge listed in the premium is eligible to judge any classes offered.

Dogs being handled by the same person will be separated into different staged groups.

Height Divisions: Dogs 15" and under - Small
Dogs 15.1 to 22" - Medium
Dogs over 22" - Large

Awards: Ribbons will be awarded for first through fourth place in Novice A, Open A, Senior A and Master A & B classes in each height division. All other B classes will receive first through fourth place ribbons overall. Qualifying ribbons will be awarded for all qualifiers in the regular classes and the Instinct test. High In Class rosettes will be offered in Novice A, Open A, Senior A and both Master A and B classes. Title rosettes will be awarded to all dogs earning a title including CZ8, RATCH, RATCHX and higher.

These trials will be held indoors on a concrete floor; all rings will be fully matted. There will be crating space available, but make sure your crate is secure as the dogs may be highly excited. You may wish to bring a ground cover.

Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of the requirement per BHA regulations.

Bitches in Season: Bitches in season are eligible for entry, but will be required to be kept separate from all other dogs and will be run in panties at the end of their class. Entry fees for bitches that come into season will be refunded until Monday June 29, 2026 if you wish to withdraw. No entry fees will be refunded after that date. If bringing a bitch in season, you must inform the Trial Committee prior to the trial and all exhibitors at the judge's briefing.

Loud/Disruptive Dogs: Dogs that are loud and disruptive may be asked to locate away from the rings/crating area. Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or Trial Committee. Terrier sparring is not allowed on the trial grounds.

Refunds: No refunds will be made after the entry deadline unless a replacement entry is available. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public event or any other cause beyond the control of the organizing committee.
