Day of Show entries will be accepted until 7:30am each day. Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

Payment and Entry Information:

Mailed entries will NOT be accepted without a Barn Hunt number, signatures and payment. Entries are invalid without a signed Release Agreement Form. Owners are responsible for entry errors. Please write clearly and proof your entry. Incomplete forms and returned checks are invalid entries. Entries are accepted on a first come/first served basis. You will receive confirmation when your entries are received. Entry via www.secreterrier.com is preferred. Move-ups will be allowed trial to trial and day to day.

Returned Checks:

A returned check does not constitute a valid entry, There will be a \$50.00 fee for all returned checks.

Cancellation Policy:

Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as fire, flood, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.

Withdrawals:

Withdrawals received by the Secretary prior to the closing date will receive a full refund, less any processing fees incurred by the club. Requests for refunds must be made by the closing date.

Refunds:

Refunds offered only for injured or sick dogs with veterinary note. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.

Trial Information:

- These trials are open to all breeds and mixed breeds registered with the Barn Hunt Association.
- They will be held indoors on rubber mats over concrete.
- Ample indoor crating is available. Vehicle crating is allowed.
- Blinds are 13 x 16 (#1) and 10 x 20 (#2) curtained areas, indoors.
- 6 dogs per blind in Instinct, Novice and Open. 5 dogs per blind in Senior, Master and Crazy 8's.
- Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.
- Move-ups are allowed from Trial to Trial and Day to Day. See the Secretary to initiate a move-up.

Animal Safety:

The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and physically able to perform all course elements. Awards:

Ribbons will be awarded for all qualifiers in all classes. Ribbons will be awarded for 1st-4th place in each height division of the A & B classes. A High In Class Award will be offered in each A class and Master B Class. Title Ribbons will be awarded to all dogs earning a title. Ribbons must be picked up at the trial, they will not be mailed.

Volunteers:

As is the case with all dog sports, volunteers are critical to the success of every Barn Hunt trial. The best way to learn is to volunteer! Please contact a committee member to volunteer for this trial or offer your services when workers are called for. Many jobs do not require previous training or experience. We appreciate you!! Volunteers will be provided with lunch, snacks and refreshments, as well as a punch card for future trial entries.

Exhibitor Information:

Bitches in Season are eligible for entry but will be required to wear panties at all times, will crate and potty separate from all other dogs and will be run at the end of their class/trial. If you are bringing a bitch in season, please inform the trial secretary as soon as possible prior to the trial and inform all exhibitors at the general briefing. Entry fees for bitches that come into season will be refunded until the closing date of the trial if you wish to withdraw. After the trial closes entry fees will not be refunded.

Smoking and/or vaping are not allowed in the building or on trial grounds.

There may not be running water available on site. There is an ADA accessible portable toilet. We may have non-potable water available, but advise you to plan accordingly for water for yourself and your dog(s).

Dog Management:

All dogs must be on a short leash and under control while on trial grounds except while showing. **RETRACTABLE/FLEXI LEASHES ARE NOT PERMITTED ON TRIAL GROUNDS.** Refer to the Barn Hunt Rulebooks for additional collar restrictions.

Pick up after your dog and dispose of waste in appropriate (outdoor) containers on the property. Any exhibitor failing to pick up after their dog may be fined and/or excused without benefit of a refund if the Event Committee determines the exhibitor to be in violation of this requirement.

Exhibitors can only enter classes they are eligible for at time of entry. Dogs who complete a title at a trial may move up in the next trial. Please make move-up requests at the Trial Secretary's desk as soon as possible. Handlers are responsible for making the request in time for the move-up to be processed.

Dogs will be run in an order determined by the Trial Secretary with dogs being handled by the same person separated into different blinds. All requests for running order changes must be approved by the Scribe / Blind Steward.

Food:

Food and beverages will be provided for volunteers. There are many restaurants, gas stations and stores within a 5 minute drive either east or west.

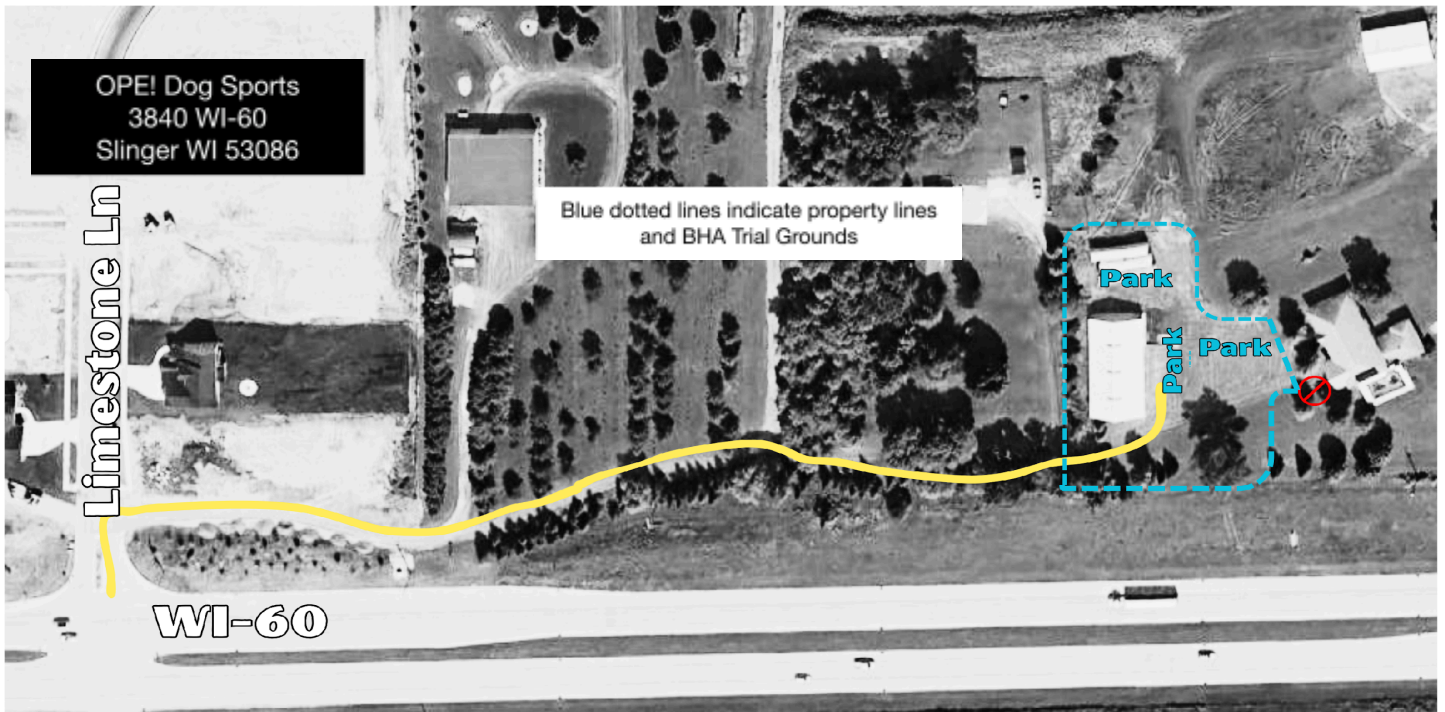

Directions: OPE! Dog Sports is located on the north side of WI-60 between I-41 and US-45. Turn north onto Limestone Ln, then **immediately** turn right onto the long shared driveway. Proceed on the driveway (yellow solid line on the map) past the brick pillars and gate into the OPE! property (bounded by blue dotted lines on the map). The OPE! Building is located to the left once you drive past the pillars and gate.

Dog Exercise Areas are located to the south and west of the building and parking lot. Look for waste bag stations. To respect our neighbors, please stay within Barn Hunt Grounds when walking dogs.

Parking: There is ample parking on the property. There are handicapped parking stalls in front with easy accessibility to the building. Parking is allowed on the asphalt paved parking lot on the east and north side of the OPE! building. Do not park on the grass. Please don't block driveway access for the house to the east.
