- Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. When possible, dogs will be staged in groups of 6 or less.
- Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.
- Move ups are at the handler's discretion. The Trial Secretary will accept move up requests and any additional applicable fees until 10 mins after the conclusion of the relevant trial/class.

Entry Information

- Dogs are required to have a Barn Hunt Registration Number to compete in a Barn Hunt Trial. In order to get your dog a Barn Hunt Registration Number, you can register your dog(s) online at <https://www.barnhunt.com/register.html> **You cannot submit an entry without a valid Barn Hunt Number**
- All dogs must be entered in only one class level and type per trial. **Double-entry per trial is not offered at this trial.** Dogs may enter both the Instinct Test and Novice Class in the same Trial until the dogs has earned the RATN Title. Then you may no longer enter Instinct.
- Entries will be accepted by mail and thru Secreterrier (*new*). Payment will be accepted through Secreterrier unless mailing in an entry. Mail in payment methods include cash or cheque. **An entry is not considered valid until payment is received.** A returned cheque does not constitute a valid entry and a \$50 dollar fee applies for all returned cheques.

- Any dog behaving in a threatening or aggressive manner toward another dog and/or person may be dismissed from the trial if justification is found to do so by the judge and/or the trial committee.
- The safety of the dogs and the rats are our number one concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are

familiar with and physically able to perform all course elements.

- All dogs must be on a short leash and under control while on trial grounds, except while showing. **Flexi leashes are not permitted on site.** No electronic collars, bark collars, muzzles, or head halters are allowed on Barn Hunt show grounds. Per Barn Hunt Association rules, all pinch collars must be covered

Withdrawal & Refund Information

- **Refunds: refunds will not be given unless there is someone on the waitlist to take your spot.**
 - Refunds will be offered for sick or injured dogs with a vet note up until one week of the trial entry close October 23/2026 at 5pm.
 - If you are on the waitlist and do not get into the trial, Secreterrier will refund your waitlisted runs upon request.
 - If you scratch your runs after the trial has closed, you forfeit those entry fees.
 - Entry fees will not be refunded in the event that the dog is absent, disqualified, excused or barred from competition by action of the event committee.
- **Bitches in season:** are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until the closing time of the trial if you wish to withdraw. After the trial closes, no entry fees will be refunded. If bringing a bitch in season, the trial secretary must be notified prior to the trial. Failure to do so will result in a disqualification and a dismissal from show grounds.
- **Cancellation Policy:** Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as fire, flood, etc. the event may be cancelled. We will make every attempt to contact entrants and inform them of the cancellation. Entry fees will be refunded as appropriate.

Event Grounds/Ring & Blind Information

- Pick up after your dogs and dispose of waste in the appropriate containers on site.
- Event grounds include the private property located at 1739 Courtright Line, Bridgen ON specifically the training building parking lot and surrounding grass areas. The training building is accessible by the east side driveway entrance, indicated by the Canine Companion Training Academy sign. Ample parking is provided.
- Event grounds are not wheelchair/handicapped accessible.
- There is a portable washroom available on site.
- There is limited restaurants options near the trial. Please bring adequate food and water for yourself and your dog(s)
- Competitors are required to crate out of their vehicles. **There will be no indoor crating.**
- 1 Ring is located indoors with rubber floor matting over a cement floor, enclosed with a 4' PVC fence.
- The Blind area is 12'x45' and is located 20' from the ring gate. Each competitor will exit the blind in order, not crossing paths of another competitor.
- **No toys or food will be permitted in the ring.**

Ribbons & Awards

- There will be ribbons for qualifiers
- There will be placement ribbons: 1st thru 4th in Novice, Open, Senior and Master classes in each height division.
- Dogs that earn a Barn Hunt Title RATN or Higher will receive a title rosette.
- High in Class ribbons will be offered in Novice, Open, Senior And Master, both A & B.
- Additional Prizes may be offered.

Photography

- An official photographer may be on site during this trial.
- **By entry of this event,** you acknowledge that you are aware and accept the fact that you and/or your dog may be photographed/filmed and that these photographs/videos may be used by Canine Companion Club as well as the photographer for promotional releases.

- Any photos taken by the official photographer during the trial will be available to purchase after the event.
