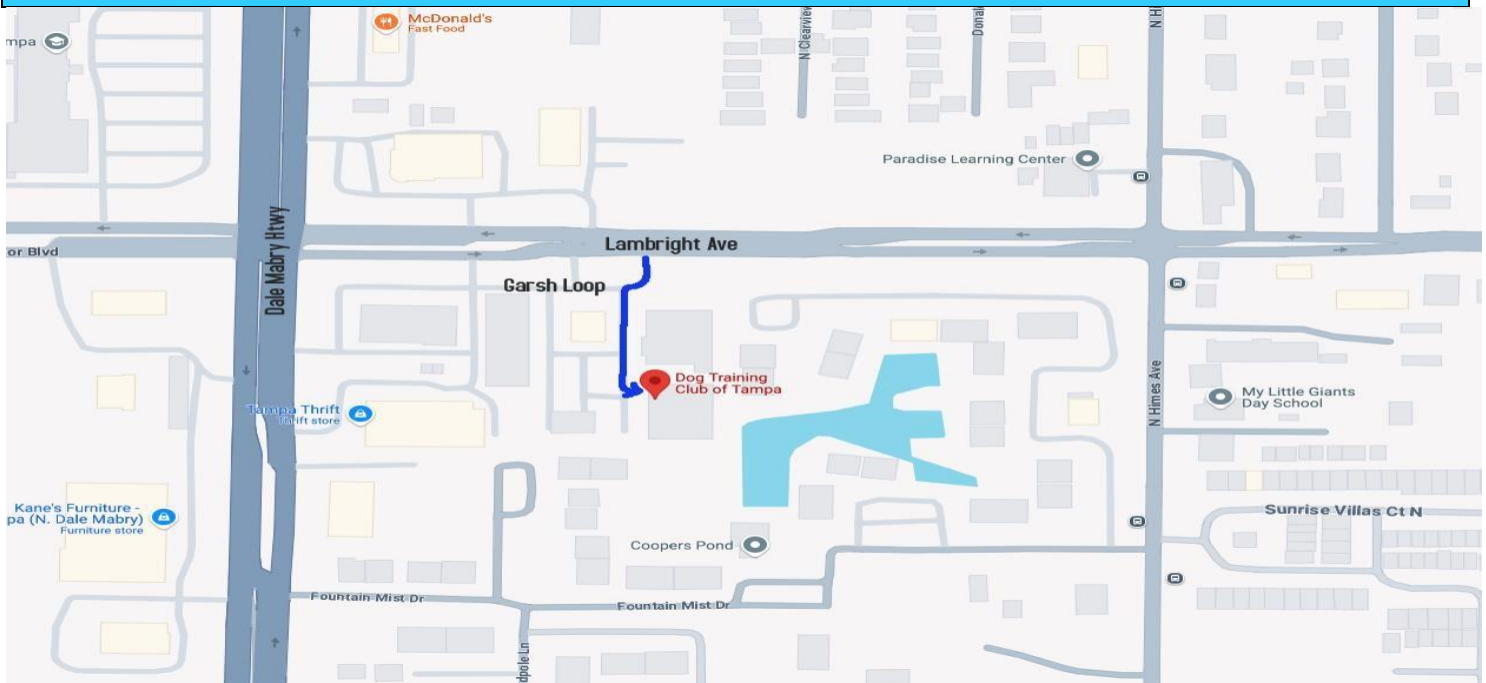
From the North and South: Follow I-275 to the Sligh Avenue exit (Exit 48). Turn west on Sligh Avenue. Continue 2.8 miles on Sligh, which takes a slight turn south and becomes Lambright St. Turn left after the light at Himes Avenue (just before Dale Mabry Highway) between Brooklyn Diner and Pizza and the Southeast Player Development. The DTCT building is behind the Southeast Player Development.

Bitches In Season: Will be run at the end of each class. BIS are required to run the course wearing pants/britches and at all times when not being pottied. Owners of BIS should crate/confine their dogs in the BIS room, (available upon request) and potty the dog away from other competitors. Owners of BIS should make their condition known to the Trial Secretary prior to arrival, if possible, and no later than 15 minutes before the start of the first trial. Entry fees (minus recording fees) will be refunded if BIS is withdrawn from the trial.

AWARDS

Placement ribbons will be awarded for 1st - 4th place in all regular classes (not Instinct) in each height division. Brown qualifying ribbons will be awarded for all qualifiers in the regular classes. New Title Ribbons will be awarded to those who qualify for them and for dogs first pass in the Instinct test. High in Class Medals will also be awarded in each class. RATCH/X ribbons are customized for Title winners. **Customized Tabs available for \$10 each (dogs name and date, plus little rat) See Karen Wood.**

NOTICE TO EXHIBITORS

*Registration number and Barn Hunt Regulations may be obtained on the website www.barnhunt.com

***Refund:** Refund will be given for entries pulled before the pre-entry date, minus transaction fees. Withdrawals must be by request using Secreterrier or submitted in writing via email or mail.

No refunds/credits will be issued if the dog is absent, disqualified, excused, or barred by the DTCT BH committee or BHA, or if the handler is ill or injured.

No refund/credits for bitches in season as they are eligible to compete.

Every attempt will be made to hold the event as scheduled. In the event of an "Act of God" such as flood, fire, hurricane, or civil disturbances beyond the control of the organizing committee, the event may be canceled. We will make every attempt to contact the entrants. In the event of a disturbance, refunds/credits will be at the organizer's discretion.

Stripe payments will be refunded less the fees collected by Stripe on the original payment. DTCT does not get any part of that fee.

- * Bring a chair for yourself and crates for your dog(s).
- * Please make sure your crate is secure as the dogs may be overly excited. If your dog is overly excited, please do not leave him/her unattended if they bark.
- * Any dog of any breed or mix, six months of age or older, may participate in Barn Hunt Trials.
- * Wolf crosses are not allowed in Barn Hunt per official rules.
- * Dogs must be able to fit through an 18" wide by approximately 22" high "tunnel" made of straw/hay bales.
- * Height Divisions: Small, Dogs 15" & under; Medium, Dogs 15.1" to 22"; Large, Dogs over 22". Dogs are measured at the option of the judge.
- * Possessing or training with personal, live quarry is not permitted on the show grounds at any time.
- * All dogs must be on leash at all times except when in the ring for judging. Please be mindful of other exhibitors and keep your dog close to you. We may ask you to cover your dog's crate or remove them from the crating area if they're excessively loud. * **Exhibitors are responsible for being ready to go in blinds and for not holding up a class. The club has no obligation or responsibility to search for or locate a dog not brought to the blind when required.**
- * Owners are responsible for errors made on entry forms, whoever may have made such errors.
- * DTCT assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, vehicles or children. * **Exhibitors are responsible for cleaning up after their dogs! Do not let your dogs pee on anything man-made. It is grounds for immediate dismissal and possible suspension from BHA if you do!**
 - The blind will be loaded with 4 or 5 competitors at a time to maintain safe distancing.
 - Dogs may enter the Instinct and Novice class in the same trial until the dog has earned the RATN title.

ENTRY FEE AND DEADLINES

Entries will be accepted in order received. Your entry must be complete with BHA number and signed with liability waiver initialed, or they will not be accepted. No notification will be sent out regarding invalid entry. New to Barn Hunt? Your dog is an "A" class, if you title and want to stay at that level your dog moves to "B" class. **Exhibitors can only enter the classes they are eligible for at the time of entry**
